#### Major business groups to partner for Community Skill Development parks

Several major national and international groups are partnering with the state government's Community Skill Development (CSD) parks that will impart skill development programmes aimed at improving the capacity of youth to equip them for jobs.

The proposal by the State higher education department is to open 17 community skill parks to impart employable skills. Of this, nine parks will commence functioning in April. The first of these parks was inaugurated by Chief Minister Pinarayi Vijayan on 2<sup>nd</sup> February, 2019 at Kulakkada in Kollam district.

IBM will be partnering in Kalamassery park while Apollo Medskill will be at Pandikkad in Malappuram district. In Kollam, Kulakkada park is partnered by Synchroserve and a consortium of eight Singaporebased companies. In Mananthavadi, it is Cairns, while Central Institute of Plastic Engineering and Technology partners in Lakkidi, Wayanad.

Meanwhile, Sahsra Group will be the consortium partner in Kunnanthanath, Pathanamthitta. In Palakkad, INSAF Group will partner CSD while in Kasargod Marine College which is part of CMC group will be partnering the project. At Perambavoor, Perumbavoor Mar Gregarious Educational Society will be the partner.

These skill parks will provide training to youngsters according to the need of the industry and operating partners can call for application from prospective candidates for this project. However, 30 percent of the seats are for those proposed by the state government and those students who come under the reservation category will get 40 percent fee reduction. Training is from 3 weeks to 6 months and courses offered include specialisation in Artificial Intelligence, Robotics, Big Data Analysis. The course fees range from Rs 10,000 to Rs 60,000.

The consortium will give high priority on entrepreneurship development. There will be special courses directed by ASAP either directly or through skilled partners, at the park. The government is for sustainable and total development of the state through comprehensive development of Community Skill Development parks. Higher Education Minister K T Jaleel, told Express: "We are ushering this programme to equip youth for the volatile job market arising in India and abroad."

#### Deloitte to provide education, skills training to 10 mn girls, women by 2030 in India

The exercise will be carried out under its global initiative WorldClass. The initiative aims "to support 10 million girls and women by 2030 through education and skills development," it said.

It said that globally, the WorldClass initiative seeks to prepare 50 million people to be better equipped for the future of work, in line with the United Nations' Sustainable Development Goals (SDGs). Deloitte's WorldClass programme in India will focus on improving girls' retention rate in school, higher educational outcomes, and skills development for women to access employment, it added. Under the initiative, partnerships will be launched with organisations such as Katha and Pratham. These organisations are working to improve the learning outcomes of millions of children and young people in schools and communities across India.

Our goal with WorldClass is to empower 50 million people globally by 2030, by providing them access to the education and skills required to find meaningful work in the new economy," Punit Renjen, Global CEO, Deloitte said. The world is on the brink of a seismic shift with the emergence of the Industry 4.0 wave, and to thrive in it, "we must work together so that no one is left behind, he said.

Across India, he said, almost 40 percent of girls aged 15-18 years drop out of school and college, and only 26 percent of women are employed. As one of the emerging economies on the world stage today, India's demographic dividend forms an integral component of its growth story. The task of harnessing its power has to be fuelled by the private sector," a Deloitte India spokesperson said.

#### **OSDA launches Odisha Skills to identify talents**

Odisha Skill Development Authority (OSDA) launched Odisha Skills-2019 on 27<sup>th</sup> February, 2019. The initiative will help identify the best talent who could represent India at the World Skills International Competition and bring laurels to the country.

Speaking on the occasion, Minister for Skill Development and Technical Education (SD&TE) Usha Devi said Odisha Government is committed to promote quality skill development in the State and provide opportunity to youth for competing at the world level.

The initiative will showcase 45 skills ranging from construction and building technology, creative arts and fashion, information and communication technology, manufacturing and engineering technology, social and personal care besides transportation and logistics.

Chairman of Odisha Skill Development Authority (OSDA) Subroto Bagchi said a target has been set for at least one lakh registration for Odisha Skills 2019 competition. The online registration will continue till May 31, he said.

Secretary of SD&TE Sanjay Kumar Singh said Odisha is the only State which has started preparation for the 2021 World Skills Competition. The Government has been selected for APJ Abdul Kalam Award 2018 for skill development in the State, he added.

On the occasion, MoUs with NIT-Rourkela and SMC Corporation India Ltd were signed for promotion of skill development. Winners of various events of Poly and ITI Fest-2019 were felicitated at the valedictory ceremony held subsequently.

Among others, CEO of OSDA-cum-Director of Employment Rajesh Prabhakar Patil and Director of DTE&T Balwant Singh were present.

#### Dharmendra Pradhan inaugurates Skill Development Institute's main campus

Union Minister for Skill Development and Entrepreneurship Dharmendra Pradhan has inaugurated the Primary campus of Skill Development Institute (SDI) near Bhubaneshwar.

The institute is located in Taraboi village of Jatni area, nearly 35 km from the Odisha's Capital. The main campus of the institutes spread over 46 acres of land includes academic block, administrative building, workshop and other facilities.

President Ram Nath Kovind laid the foundation stone for the main campus on March 18 last year.

"Students will get world-class education and training here so that they can work in different parts of the world," Pradhan said while inaugurating the institute.

The expansion of the institute under first phase is already over whereas the second and third phase are likely to be completed by the year-end. Around Rs. 300 crore has been earmarked for the construction of the institute.

Managed by Indian Oil Corporation Limited (IOCL), SDI has been functioning from Mancheswar industrial estate in the city since May 9, 2016. Currently, the institute is offering courses in seven trades and providing employability skills training to about 200 students per batch.

The Institute through its new campus is supposed to impart skill development training to over 50,000 students in 25 regular trades keeping the demand in mind in sectors like hydrocarbons and other industries.

It will offer entrepreneurship programmes of national and global interest. Specific local needs will also be taken care of to promote jobs in the local industry. (Skill Reporter, New Delhi – 26 February, 2019)

#### No compromise on quality of skill training, surprise inspections to take actions against nonperforming centres: MD JKSDM

With the aim to ascertain the quality of the training being delivered at its registered training centres, J&K Skill Development Mission has undertaken a week long inspection drive across the valley which commenced from 18<sup>th</sup> February, 2019. The Mission has empanelled 82 centres for implementing the state component training under PMKVY (Pradhan Mantri Kaushal Vikas Yojana). PMKVY is a centrally sponsored scheme of Ministry of Skill Development and Entrepreneurship; Government of India aimed to enable youth to pursue industry relevant skill training that will help them in securing a better livelihood.

Jammu and Kashmir Skill Development Mission has empanelled 82 training centres under PMKVY and 54 centers are currently functional with 28 and 26 centres in Kashmir and Jammu divisions respectively.Officials of JKSDM led by Mission Director, JKSDM conducted surprise inspections of various training centres operating in north, central and south regions of the valley. The Sub-Divisional Magistrates of Sumbal and Chadoora also accompanied Mission Director, JKSDM in their respective areas. The training centres are currently imparting training in skill courses such as Domestic Data Entry Operator, Assistant Electrician, CCTV Installation, Retail Associates, Plumbing, Self- Employed Tailor, Field Technician and Computer and Peripherals.

During inspections, the team inspected facilities such as classrooms, CCTV installation, biometric attendance and presence of training staff/candidates at these centres and also checked records of these centres.

While appreciating training centres especially Douze Construction & Engineering services Pvt. Ltd., Magam, National Paramedical Sciences society, Magam, Advanced skill development centre, Pulwama, Asian institute of computer education & training, Pulwama and Northtel, Srinagar ,MD JKSDM said, "All those centres who are imparting quality training for gainful employment will be supported by the Mission, but action will be taken against non performing centres and the centres who are violating scheme guidelines".

Most of the centres were found functioning in a satisfactory manner and adhering to the norms and guidelines that are in place for training centres to follow. To encourage training centres where infrastructure and delivery of training was of quality standards, it was decided to allocate more training targets (candidates) to such centres under PMKVY.

However, during inspections, some of the training centres were found guilty of not operating as per scheme guidelines. The management team of such training centers was apprised about their deficiencies instantaneously and it was decided to penalize such centres with rejection of student batches enrolled by them and withholding of their payments.

"Certain training centres were found indulging in malpractices which were in contravention to the norms and guidelines of the scheme. In such cases, cancellation of the empanelment and blacklisting for the future is being considered by the Mission," said official of JKSDM. The official added, "JKSDM has decided to deal the situation with an iron fist and appropriate measures which include penalties, blacklisting etc will be taken against the training centres for non-compliance of the norms and guidelines of the training schemes." ## **Skill development scheme in Bihar**

#### 430. Shri Ram Nath Thakur:

#### Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) whether it is a fact that training and employment were to be given to the unemployed youth under skill development scheme;
- (**b**) if so, the details thereof; and
- (c) the number of unemployed youth who were imparted training and the number of youth who got employment out of them during the last two years in Bihar so far, the details thereof?

#### Answer

#### Minister of State in the Ministry of Skill Development and Entrepreneurship (Shri Anantkumar Hegde)

(a) to (c) Under Skill India Mission, Ministry of Skill Development and Entrepreneurship is implementing a flagship scheme known as Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2016-20 with an objective to provide skilling to one crore people under Short Term Training (STT), Recognition of Prior Learning (RPL) and Special Project (SP) across the country for four years i.e. 2016-2020 with an outlay of 12,000 crore.

Under PMKVY 2016-20, as on 24.01.2019, 1.71 lakh (appx.) candidates have been trained under STT (1.23 lakh), RPL (0.47 lakh) and Special Project (0.01 lakh) in the State of Bihar. Under PMKVY 2016-20 scheme, placement tracking is mandatory. The placement data is reported within 90 days of certification of trained candidate. As per data reported on SDMS, as on 24.01.2019, 0.99 lakh candidates are certified under STT and SPs of PMKVY 2016-20 in the State of Bihar. The number of candidates certified under STT and SPs of PMKVY 90 days prior i.e. 26.10.2018 is 0.89 lakh. Out of these candidates, as on 24.01.2019, 0.43 lakh candidates have been placed in various sectors. **(Rajya Sabha, New Delhi – 6 February, 2019**)

# Rajya Sabha Unstarred Question No. 1220 answered on 13.02.2019

#### Skill development for unemployed youth

#### 1220. Shri Harnath Singh Yadav: Shri Vijay Pal Singh Tomar: Shri P. Bhattacharya:

#### Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) the details of the schemes currently being run by Government for skill development of the unemployed youth in urban and rural areas of the country; and
- (b) the number of people benefited with these schemes during the last two years along with the number of youth provided with avenue of employment?

#### Answer

#### Minister of State in the Ministry of Skill Development and Entrepreneurship (Shri Anantkumar Hegde)

(a) to (b) Under Skill India Mission, the Government of India is implementing around 40 programmes through more than 20 Central Ministries/Departments for skill development. Ministry of Skill Development and Entrepreneurship (MSDE) is implementing schemes for imparting employable skills to the youth through short term and long term program. The Pradhan Mantri Kaushal Vikas Yojana (PMKVY) implemented by MSDE provides short term training to the youth through affiliated training partners/training centres, both in urban and rural areas. Long term training is provided through Industrial Training Institutes (ITIs). There are 15,044 Industrial Training Institutes (ITIs) functioning in the country affiliated with National Council of Vocational Training which provide training to 26.43 Lakhs students. Under PMKVY 2016-20, 29.66 Lakhs persons have been trained during the last two years. The Directorate General of Training under Ministry of Skill Development and Entrepreneurship is also providing various vocational/skill training programs through a network of 15 National Skill Training Institutes (NSTIs) and 18 National Skill Training Institutes (Women) (NSTIs-W) in various urban and rural areas of the country. The trainees trained by the NSTIs during 2016-17 are 27,410 and during 2017-18 are 29,345 trainees.

In addition, Ministry of Rural Development is running Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU- GKY) scheme for rural areas in which 1.13 Lakhs and 3.17 Lakhs have been trained during 2017-18 and 2018-19 (till June, 2018) respectively. Ministry of Housing and Urabn Affairs is running a programme Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) for urban areas in which 2.48 Lakhs and 3.98 Lakhs have been trained during the year 2017-18 and 2018-19 respectively. **(Rajya Sabha, New Delhi – 13 February, 2019)**

#### Skill Development in Micro, Small and Medium Sector

#### 227. Shri Raju Shetty:

#### Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) whether the Government has launched/proposed to launch Skill Development Programme in the country including Maharashtra;
- (b) if so, the details thereof and the number of beneficiaries covered/likely to be covered under the programme;
- (c) whether the rate of employment generated in the Micro, Small and Medium Sector is not as per the growth rate of investment;
- (d) if so, the details thereof along with the reasons therefor; and
- (e) the reaction of the Government in this regard?

#### Answer

#### Minister of State in the Ministry of Skill Development and Entrepreneurship (Shri Anantkumar Hegde)

(a) & (e) Ministry of Skill Development and Entrepreneurship through National Skill Development Corporation is implementing its flagship scheme Pradhan Mantri Kaushal Vikas Yojana (PMKVY). Owing to the success of PMKVY 1.0 over 19 lakhs people were trained, the scheme was re-launched with an aim to train 10 million youth pan India by 2020 and is called PMKVY 2016-20. As on 24.01.2019, under PMKVY 2016-20, more than 35 lakh candidates under Short Term Training, Recognition of Prior Learning and Special Projects have been trained of which over 10 lakh have been placed. Out of these, 1,80,293 candidates were trained and 25,271 have been placed in Maharashtra. Under the administrative control of Development Commissioner, MSME, two institutes i.e. IGTR Aurangabad and IDEMI Mumbai are functioning in Maharashtra State. These institutes conduct skill development programmes for youth. Total 1,47,033 and 1,29,825 trainees were trained during 2017-18 and 2018-19 (till Dec, 2018) of which 20,156 and 16,615 were trained in Maharashtra.

Ministry of Micro, Small and Medium Enterprises (MSME) is implementing a scheme called Prime Minister's Employment Generation Programme (PMEGP). The scheme aims to generate employment opportunities in rural as well as urban areas of the country through setting up of new selfemployment ventures/ projects/ micro enterprises. Ministry of MSME also implements several other schemes and programmes to strengthen the MSMEs and promote employment. Some of the important initiatives in this regard include Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Mission Solar Charkha, A Scheme for promoting innovation, Rural Industry & Entrepreneurship (ASPIRE), Credit Guarantee Fund Scheme, Credit Linked Capital Subsidy Scheme (CLCSS), National Manufacturing Competitiveness programme (NMCP), Marketing Assistance Scheme, MSE-Cluster Development programme etc. Apart from these, employment opportunities have also been created under Pradhan Mantri Mudra Yojana (PMMY).

The National Sample Survey Organisation (NSSO), Ministry of Statistics & Programme Implementation, conducted a survey of unincorporated non-agricultural enterprises (excluding construction) during its 73rd round (July, 2015 – June, 2016). As per this survey, the total employment in the MSME Sector is 1109.89 lakh. (Lok Sabha, New Delhi – 4 February, 2019)

# Lok Sabha Unstarred Question No. 1304 answered on 11.02.2019

#### **Skill Development / Employment**

#### 1304. Shri Raju Shetty:

#### Will the Minister of Skill Development and Entrepreneurship be pleased to state:

- (a) whether in reality Skill Development Programme Fund helpful in generation of employment opportunities in the country, if so, the number of youths or persons trained under this scheme since inception of the programme, State/UT-wise;
- (b) the number of small scale industry units which have been started due to this skill development, State/UT-wise; and
- (c) the details of the financial help rendered for these startups?

#### Answer

#### Minister of State in the Ministry of Skill Development and Entrepreneurship (Shri Anantkumar Hegde)

(a)to (c) There is no Skill Development Programme Fund under the Ministry of Skill Development and Entrepreneurship however, there is a Trust namely National Skill Development Fund (NSDF) which was incorporated on 23.12.2008 as a trust under the Indian Trust Act, 1882 fully owned by the

Government, to act as a receptacle for financial contributions from Governmental sources, bilateral/ multilateral and other agencies and other private sector donors who would prefer to provide funds through the Government. NSDF meets its objectives through National Skill Development Corporation (NSDC) which is an industry led Company registered as a Not for Profit Company under section 25 of the Companies Act, 1956 setup for building skill development capacity and forging strong linkages with the market.

Ministry of Skill Development and Entrepreneurship through National Skill Development Corporation had implemented Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2015-16 with the objective to enable a large number of Indian youth to take up industry-relevant short duration skill training. About Rs.1335 Crore had been released to NSDC from NSDF for implementing the scheme in the country. Under this scheme, 19.85 Lakh candidates had been trained in 375 job roles. Under PMKVY 2015-16, it was not mandatory for NSDC's training partners to report employment data. The employment data available reflects only a fraction of the actual employment provided under the scheme. Out of the total trained candidates, around 2.62 lakh candidates have been reported as placed.

Further, Pradhan Mantri Kaushal Vikas Yojana (PMKVY) to skill one crore people over the four years (2016-2020) with an outlay of Rs. 12,000 crore is also being implemented by the Ministry. Under PMKVY 2016-20, the skill development training is running with accelerated pace with an objective to provide skilling under Short Term Training (STT), Recognition of Prior Learning (RPL) and Special Project (SP) across the country. Under PMKVY 2016-20, as on 24.01.2019, 37.32 lakh (appx.) candidates have been trained under STT (25.25 lakh), RPL (11.27 lakh) and Special Project (0.8 lakh) in the country.

Under tripartite Corporate Social Responsibility (CSR) Agreements, various Public Sector Undertakings (PSUs), private sector donors provide funds to NSDC through NSDF for implementation of CSR Skill Development Projects. Since inception, 27,571 youth have been placed under the CSR projects with various employers across the country that is inclusive of self and wage employment. The growth in the numbers, over the years, has been gradual and steep because of the increase in number of funders who have shown interest in spending their CSR fund in skill initiatives in this span of time; and the number of project renewals that has happened in the last two years. Moreover, around 40000 beneficiaries have been certified under Corporate funded Recognition of Prior Learning (RPL) of workers and contract workers, especially under Mining sector.

FICCI Skill Committee Meeting 2019

The first meeting of the year for FICCI Skill Committee was held on 7<sup>th</sup> February, 2019, at Federation House, FICCI, New Delhi. The Geospatial industry comprises of government organizations, private companies, non-profit organizations, and academic and research institutions that develop, manufacture, research and employ geospatial technology. They are involved in gathering, storing, processing, integrating, managing, mapping, analyzing and distributing data tied to a location on Earth.

**Geospatial Technologies** include Geographic Information System (GIS)/Spatial Analytics, Global Navigation Satellite System (GNSS) & Positioning, Earth Observation, and Scanning, Remote Sensing, Computer-aided design. **Geospatial Disciplines** includes Surveying, Geodesy, Mapping, Cartography, Remote Sensing, Geographic information science, etc.

To discuss the skilling opportunities in Geospatial sector an Expert Committee has been set up by the Ministry of Skill Development and Entrepreneurship (MSDE), under the Chairmanship of Surveyor General of India wherein CEO SCMS has been invited to be a part of this Committee. The first meeting of the Expert Committee was held on 18<sup>th</sup> February, 2019 at the office of Surveyor General of India, Dehradun.

#### Modi government eyes a comprehensive makeover for Skill India Mission

The government is considering revamping the Skill India Mission, which has not achieved the desired results despite a series of initiatives. Officials said the mission in its new avatar will be based on incentives rather than subsidies and it will focus largely on fiscal sops for attracting private players.

A senior government official told ET that there have been internal deliberations on how to make skilling more effective so that the quality of skill training matches international standards and the outreach of skilling is massively scaled up to cover millions of youths that enter the workforce every year.

"One of the options being considered includes giving fiscal incentives to private players whose skilling targets could be linked to their annual turnover," said the official, speaking on condition of anonymity. The plan also envisages incentivising the youth through stipends at the school level to join vocational courses once the skilling ecosystem is integrated with the secondary school curriculum.

NITI Aayog has also suggested that the government give incentives to private schools and lower interest rates on loans to create and expand skills-related training infrastructure at the secondary school level.

Prime Minister Narendra Modi had launched the Skill India Mission in 2015 with a vision to make India the "skill capital" of the world.

The government's stated aim was to impart skills training to 400 million people by 2022 through schemes such as the Pradhan Mantri Rozgar Protsahan Yojana, Deen Dayal Upadhyaya Grameen Kaushalya Yojana and National Apprenticeship Promotion Scheme. However, just 25 million youths have been imparted skill training so far under various government schemes. Union Budget 2018-19 allocated Rs 3,400 crore for Skilling India, up from Rs. 2,356 crore in the previous fiscal.

"Lateral entry/exit, upward mobility and multiple classroom learning are the need of the hour," said Neeti Sharma, senior vice president, Teamlease Services India. "If students wish to continue with education, they should be allowed to continue in college and earn relevant credits. Then, if needed, let them work for a few months or quarters and come back to continue studies."

The demand for skilled labour is estimated to be over 128 million between 2017 and 2022 in 34 sectors across industries, according to the skill development and entrepreneurship ministry's annual report for 2017-18. But less than 5% of India's workforce is formally skilled, much less than that in South Korea (96%), Japan (80%), Germany (75%), United Kingdom (68%) and the United States (52%), according to the ministry's report for 2015-16. **(The Economic Times, New Delhi – 30 January, 2019)**
