Our few of the major skilling project with DMFT-Latehar (Jharkhand), DMFT-Jajpur (Odisha) and a special residential project for a batch of 30 female candidates in the job role of 'Rig Mounted Drill Operator' sponsored by MOIL are progressing well.

During the last financial year, SCMS has trained 3,128 candidates under STT & RPL out of which 2,948 candidates are certified under Govt. & Industry funded.



With the year-end specific drive for ToT and ToA, now SCMS has a galaxy of 71 Certified Trainers/Master Trainers with 293 certifications and 48 Certified Assessors/Master Assessors with 283 certifications.

SCMS has recently carried out a third-party “ Impact Study & Analysis” for the Mining Skilling Project in respect of Jumbo Drill Operators & Winding Engine Operators executed at Hindustan Zinc Limited during the period 2016-2019. MINING & EXPLORATION

India's coal production rises 15 pc in April-February period

India's coal output increased by 15.10 per cent to 784.41 million tonnes (MT) during April-February period of the ongoing fiscal. The country's coal output was at 681.5 MT in the year-ago period, as per provisional figures of the coal ministry. Coal India Ltd, which accounts for over 80 percent of coal output, produced 619.70 MT from April to February of FY23 as compared to 542.38 MT during the same period of FY22, registering a growth of 14.26 percent.

"Coal ministry has paved the way for releasing additional coal in the market by greater utilisation of mining capacities of captive coal blocks which has led to increase in production by captive and other companies by 29.83 percent to 104.58 MT (provisional figure) during Apr'22-Feb'23 as compared to 80.55 MT produced during the corresponding period of FY 22," the ministry said in a statement. The total coal despatch was at 793.86 MT during April-February period of current fiscal as compared to 740.96 MT in the year-ago period, registering a growth of 7.14 per cent. This shows steady and efficient amount of coal despatch to various sectors across the nation.

ALLIED INDUSTRY

India focusing on 300 million tonne annual steel production by 2030

Union Minister of Steel and Civil Aviation Jyotiraditya Scindia said that large scale augmentation will be done to double production from present capacity of 150 million tonnes per annum to 300 million tonnes per annum by 2030. Addressing the fourth Global Zinc Summit -2023, the minister said that the country has already emerged as the second largest steel producer in the world and our per capita steel consumption has gone up from 57kg to 78kg during the last nine years.

Scindia said that we have awarded 54 applications submitted from close to 26 companies under the Production Linked incentive (PLI) for specialty steel. The Union Cabinet in July 2021 approved a ₹6,322-crore PLI scheme to boost the production of speciality steel in India. The PLI will help to extent production capacity of 26 Million Ton per annum and investment of ₹30,000 crore with the employment generation for 55,000 people.

The Minister added that government has announced a huge capex of ₹10 lakh crore for infrastructure development which has opened tremendous investment opportunities across the sectors. Highlighting the Prime Minister's commitment to net zero carbon emission by 2030, the Steel Minister said, "we have to learn to coexist with the environment, we have to learn to respect the environment, there can no longer be a linear model of take, make and dispose. Recycling has to become a part of our existence."

Mines Ministry Approves Rs. 154.84 Crores to National Mineral Exploration Trust for Exploration & Enhancing Capabilities

The Executive Committee (EC) meeting of National Mineral Exploration Trust (NMET), Ministry of Mines was held under the chairmanship of Sh. Vivek Bharadwaj, Secretary, Ministry of Mines. Projects of mineral exploration and enhancing institutional capabilities in exploration worth Rs.154.84 crores were approved.

The mineral exploration project includes Graphite, Iron, Coal, Zinc & associated minerals, Bauxite, Basemetal (Pb, Zn & Cu), Phosphorite/Glauconitic sandstone, PGE & associated minerals (Chromium, Nickel, Cobalt), Tin & associated minerals, Manganese and Limestone to boost the mineral exploration in the country.

Financial assistance for enhancing mineral exploration and institutional capabilities of Geological Survey of India (GSI), Indian Bureau of Mines (IBM) and State DGMs/DMGs was also approved. These mineral exploration projects and financial assistance to the exploration agencies will provide auctionable mineral blocks to the nation and will help in realizing the Aatmanirbhar Bharat in mining sector.

Govt putting in all efforts for skill development of tribal youth: PM Modi

Prime Minister Narendra Modi on 14th February, 2023, Tuesday said that the Union government is putting in all efforts on promoting the tribal arts and enhancing the skills of tribal youth of the country. Speaking after inaugurating the national tribal festival-Aadi Mahotsav at Major Dhyan Chand National Stadium here, Modi said that "Tribal children may be in any corner of the country, their education and their future is the priority of the BJP government".

"New tribal research institutes are being opened in the country. These efforts are creating new opportunities for the tribal youth in their own area" he said. Talking about the Eklavya Schools, the Prime Minister said, between 2004 and 2014 only 90 'Eklavya Schools' were opened whereas from 2014 to 2022 the NDA Government has approved more than 500 'Eklavya Schools'.

"Out of these, studies have started in more than 400 schools and more than one lakh tribal students have enrolled in these schools" he said. The Prime Minister also emphasized on the infrastructure work being carried out in tribal areas and said, "A better infrastructure is being built in tribal areas and thousands of villages in the country which were earlier affected by Left Wing Extremism are being connected with 4G connectivity".

"The youth here are now connecting with the mainstream through the internet and infrastructure. Today, more than 80 lakh self-help groups are working in different states, in which more than 1.25 crore members are our tribal brothers and sisters and a large number of them are our mothers and sisters " he added. Touching upon the New Education Policy he said the Tribal youth used to face a lot of difficulties due to language barriers, but now the option of studying in the mother tongue has also been given in the new National Education Policy.

The Prime Minister said Vishwakarma Kaushal Samman Yojana has been launched in this year's budget which will provide financial assistance, skill training, and marketing support for tribal communities. During

the event Prime Minister Modi also paid floral tribute to tribal freedom fighter Birsa Munda. After inauguration Prime Minister Modi visited the various stalls put up by various states and UTs to interact with tribal artisans and view their hand looms, handicrafts and tribal products.

The aim of the national tribal festival will be to showcase the rich and diverse heritage of tribes from across the country in over 200 stalls at the venue. Around 1000 tribal artisans are participating in the Mahotsav. According to a statement by the Prime Minister's Office, the Aadi Mahotsav, which celebrates the spirit of tribal culture, crafts, cuisine, commerce and traditional art, is an annual initiative of the Tribal Cooperative Marketing Development Federation Limited (TRIFED) under the Ministry of Tribal Affairs.

This year, it is being organised from February 16- 27 at Major Dhyan Chand National Stadium in Delhi. "Since 2023 is being celebrated as the International Year of Millets, along with usual attractions like handicrafts, handloom, pottery, jewellery etc, a special focus in the Mahotsav will be on showcasing Shree Anna grown by tribals," the statement said. **(Business Standard, New Delhi – 16 February, 2023)**

Mining of oceans to unlock huge opportunities for Indian industries: Mines secretary

India is looking to mine oceans, which will unlock huge opportunities and new areas of operations for Indian industries, mines secretary Vivek Bharadwaj said. Speaking at a conference on the sidelines of the silver jubilee edition of the International Engineering & Technology Fair 2023, the mines secretary said that the government is amending the Offshore Areas Minerals (Development and Regulation) Act, which is open for comments from the industry.

"We need to increase domestic exploration and we have enlisted 13 private exploration companies as the opportunities are immense. We also need to look at acquiring foreign assets. We sent a team to Argentina to identify mines for investments and we have two lithium mines and one copper mine there. Within the coming period, we will shortlist projects to invest, which will be open to the private sector," Bharadwaj said. He also urged the industry to get into organized recycling to make India the recycling hub of the world.

Talking about the opportunities and possibilities in metals and mining industry, he said that the government has proposed amendments in the MMDR Act to encourage junior miners. Koushik Chatterjee, chairman, Metal & Metallurgy Expo 2023 and executive director and Group CFO, Tata Steel Ltd said metals and metallurgy sector is the foundation of India's economic growth and underlined the need to develop a sustainable metals and metallurgy Industry, which is aligned with India's Sustainable Development and Net-Zero goals.

Gajendra Panwar, MD, Danieli India Ltd said that the industry should build modern steel plants capable of delivering premium quality steel to become globally competitive. Noting that India needs to become carbon neutral, he said that green hydrogen is a great option to bring down greenhouse gases emissions. "But, until it is available and affordable, we must look for other technologies to use natural gases to bring down carbon emissions," he added.

Sunil Duggal, chairman CII National Committee on Mining and Group CEO, Vedanta Ltd said that the enormous potential of the mining and metallurgy sector needs to be unlocked and added that the industry is fully committed to achieve Prime Minister Narendra Modi's vision to make India Aatmanirbhar in coming years. Over 400 companies from 19 countries are displaying their latest products and technologies at the IETF. Finland is the focus country at the IETF this year. **(Livemint.com – 17 February, 2023)**

Shri Pradhan appreciated Ms. Gina Raimondo's high regard for Prime Minister Shri Narendra Modi's leadership and vision for India's fast-paced growth.

Government launches Skill Hub Portal

The Skill Hub portal was launched on 24th March, 2023 by Rajeev Chandrasekhar, Union Minister of State for Skill Development and Entrepreneurship and Electronics & IT, as part of the Government's initiatives to deliver industry-ready employable skills to young Indians in all regions of the country. The portal has invited all colleges and universities to be a part of the Skill India Network and ensures ease of access to skill training for students across in India. Chandrasekhar said that the Government under PM Modi has always emphasized the importance of industry-ready and future-ready skills for young Indians.

Karnataka's initiatives

Talking about the skilling plans in Karnataka, Chandrasekhar said, "In view of the expansion and diversification of the economy, there is going to be demands for skills. Hence, district-wise skill mapping has been carried out and unique District Skill Development Plans prepared by the government of India for each district of Karnataka." He added that the government aims to make 15 lakh young citizens in Karnataka get Industry-ready, employable, future-ready skills over the next three years. "The future economic growth and prosperity will be driven by the energy, capability, and determination of young Kannadigas. This is the vision of Nava Karnataka," Chandrasekhar said.

Highlighting the skilling achievements of the government, the Minister said a vast network of skilling has been created post-2014, and by 2022 a total of six crores of young Indians have been skilled and certified.

Pradhan Mantri Skill Development Scheme

1706. Shri Dulal Chandra Goswami:

Will the Minister Skill Development and Entrepreneurship be pleased to state:

- (a) whether the Government has done any survey to know about the benefits extended to the youth as a result of the launch of Pradhan Mantri Skill Development Scheme;
- (b) if so, the details thereof and the outcomes thereto;
- (c) the aims and objectives of the said scheme;
- (d) whether the Government has come across any difficulty while implementing the said scheme;
- (e) if so, the details thereof; and
- (f) the steps taken/being taken to address the challenges?

Answer

**Minister of State in the Ministry of Skill Development and Entrepreneurship
(Shri Rajeev Chandrasekhar)**

(a) and (b) Modern, industry-linked, future ready skills are a gateway to employment and entrepreneurship. Ministry of Skill Development and Entrepreneurship (MSDE) has been imparting Short Term Training through Pradhan Mantri Kaushal Vikas Yojana (PMKVY) since 2015. PMKVY has been implemented in three phases: PMKVY 1.0 (2015-16), PMKVY 2.0 (2016-20) and PMKVY 3.0 (2020-22). PMKVY 2.0 was evaluated by NITI Aayog in October 2020 under jobs and skills sector. The impact evaluation study draws inference of the scheme level contribution to the larger jobs and skills sector along with clear reflection of following strength and outcome achieved during implementation:

- The training provided under the scheme is relevant to the employers and they prefer candidates trained under PMKVY compared to untrained candidates.
- 52 percent of the candidates who were placed in full time/part time employment and had completed training under the RPL component received higher salary or felt that they will get higher salary compared to their peers who have no certification.
- About 94 percent of the employers surveyed reported they would hire more candidates trained under the scheme.
- About 67 percent and 18 percent of the employers surveyed reported that the overall experience with respect to the recruitment process was good and very good, respectively.
- Further, third-party impact evaluation of the scheme PMKVY 2.0 (2016-20) was conducted by the Indian Institute of Public Administration (IIPA). The impact evaluation study draws following inference:
 - The maximum percentage of beneficiaries (70.5%) received placement in their desired skill sector.

- To ensure that high standards of quality are maintained by PMKVY Training Centres, NSDC and empanelled inspection agencies use various yardsticks. These involve validations, surprise visits, and monitoring through the Skill India Portal (SIP) (erstwhile Skills Development Management System (SDMS)). These standards are intensified using the latest technologies.
- As an impact of the scheme, 118.2% change in monthly wages of beneficiary trainees has been recognized.

(c) The objective of the PMKVY is to provide industry based skill training to youth of the country to make them employable for better livelihood.

(d) to (f) The specific constraints/shortcomings/impediments that were experience during the implementation of the PMKVY and the remedial measures that have been taken for effective implementation of PMKVY are as follows:

- Shift from Supply driven approach to Demand driven approach;
- Various digital interventions have been taken for effective and transparent implementation of scheme such as Direct Benefit Transfer, Aadhaar linkage of trainers and trainees, Biometric attendance of candidate;
- All the processes are done through the Skill India Portal (SIP) whereas earlier multiple portals were there for ease of all the stakeholders. The training life-cycle of trainees, trainers, assessors and training providers are captured through the SIP;
- Technology driven intervention along with the physical inspections of the training centres, has been introduced for transparency and scalability;
- Under the PMKVY 3.0, District Skill Committees (DSCs) were involved to assess the demand of the districts for skill development training, mobilization and counselling of candidates;
- During the PMKVY 3.0, the COVID-19 pandemic caused the disruption in labour market and in order to mitigate the impact of COVID-19 pandemic and to support the healthcare system in the country, Customized Crash Course Programme for COVID Warriors (CCCP for CW) under PMKVY 3.0 was launched in June, 2021;
- For the integration of general education with vocational education and leveraging the existing infrastructure, Skill Hub Institute (SHI) under PMKVY 3.0 was launched in schools, colleges, Higher Education Institutes (HEIs), Industrial Training Institutes (ITIs), etc.

- (a) the efforts made by the Government to enhance the quality of skill development across the country to international level;

- (b) whether any contract has been signed with foreign organizations to provide quality skill training to the youth of India; and
(c) if so, the details thereof?

Answer

Minister of State in the Ministry of Skill Development and Entrepreneurship (Shri Rajeev Chandrasekhar)

(a), (b), and (c) Sir, Ministry of Skill Development & Entrepreneurship (MSDE) in order to enhance the quality of skill development across the country to international level, has undertaken various initiatives. Some of these include:

- MSDE has signed G2G MoUs with 11 nations that focus on to provide a framework of cooperation in areas like information exchange, skill harmonization, recognition of qualification etc.
- National Skill Development Corporation (NSDC) under the aegis of MSDE has signed 23 B2B MoUs with organizations/bodies in different countries to enable employer connect, on the job training, capacity building, etc.
- Bilateral Skills Benchmarking and harmonization has also been recognized as an important area of cooperation in the bilateral engagements of MSDE.
- MSDE has undertaken mapping of qualifications with Kingdom of Saudi Arabia, United Arab Emirates, and Australia.
- A Framework Mechanism for Mutual Recognition of Education and Skill Qualifications has been signed with Australia on 2nd March 2023.
- In order to increase the exposure of skilling ecosystem in India to international skills standards, MSDE has been participating in the World Skills Competition since 2007. In the 2022 edition of the Competition, India has been ranked 11th with 02 Silver Medals 03 Bronze Medals and 13 Medals of Excellence.
- Also, MSDE in collaboration with other countries has been implementing different programmes that focus on Training of Trainers (ToT), improving pedagogy and training delivery mechanism in Indian skill training institutes, internship of Indian students etc. Such programmes include Bund-Lander Programme (BLP) and Indo-German Initiative for Technical Education (IGnITE) of Germany, and Technical Intern Training Programme (TITP) of Japan.

Further, the Union Budget for the FY 2023-24 has announced setting up 30 Skill India International Centers across the country to facilitate skilled mobility from India. In compliance to this, MSDE is working on the proposal of establishing 30 Skill India International Centers across different States to skill the youth as per international skill standards to leverage the growing overseas opportunities.

SCMS IN ACTION

DMFT Angul (Odisha)

The DMFT project commenced in Angul /Odisha on 6th October, 2021 got completed in May, 2022. SCMS has trained & certified 150 local youths in the trades of Mine Electrician, Mine Welder, and Dumper/Tipper Operators. 105 trainees (which is 70% of the total enrolled) have been successfully placed /employed across the country as per the demand aggregation. The trainees are continuing in their respective jobs at their locations. The project has set benchmarks and has also proved to be motivational for other needy candidates in the region.

DMFT-Latehar

The DMFT project commenced in Latehar (Jharkhand) in April, 2022. As of now, the training and assessment for an overall 10 batches of Excavator and Loader operators are completed. On-Job-Training has been facilitated for 192 candidates and 66 candidates have been placed so far. DMFT Latehar takes the monthly review of the project where the SCMS representative participates and showcases the latest updates in front of the review board and SCMS has been appreciated time and again for its commitment, pro-activeness, and timely submission of reports as required by the DMFT officials.

The training and certifications of 300 targeted candidates were completed in January 2023. OJT and placement facilitation is ongoing.

IREL- RPL Training

IREL carries out trainings of its workforce through its own trainers, certified by SCMS. However, assessment and certifications are carried out by SCMS assessors. During the FY-2022-23, SCMS have certified **98 employees** of IREL on the job roles of Mine Electrician, Mechanic/ Fitter and Ore Processing Operators.

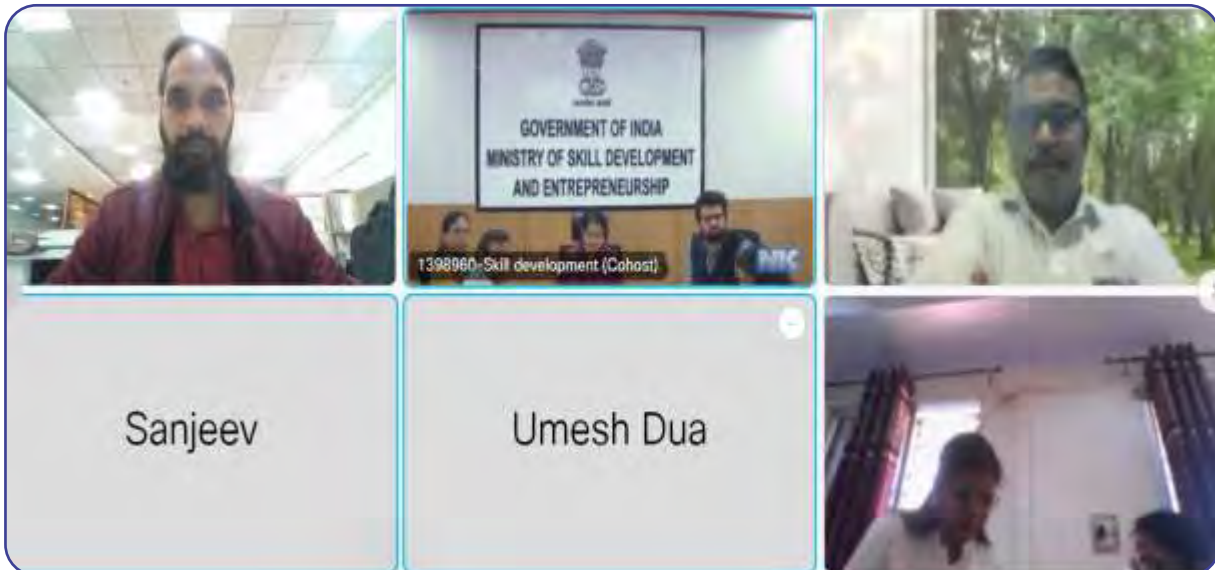

Training of Trainers/Assessors

One of the key objectives of SCMS is to create an ample pool of competent and certified trainers and assessors across all mining states on all job roles for successful and effective execution of the skill development programs. SCMS regularly keeps organizing 'Training of Trainers', (TOT) and 'Training of Assessors', (TOA) programs to ensure this. These certifications are generally valid for two years. To keep the existing pool ready for a longer duration, SCMS needs to re-assess and re-certify the existing trainers and assessors for the next two years through a one-day TOT/TOA program for existing trainers and assessors.

In line with immediate requirements for PMKVY 4.0 and PMKUVA schemes, SCMS carried out 6 one-day ToT and 6 one-day ToA programs for existing trainers and assessors during February to March, 2023 on the job roles like Bulldozer Operator, Dumper Operator, Loader Operator, HEMM Mechanic, Mechanic/Fitter, Mine Electrician, Mine Welder etc. SCMS also carried out 2 ten days ToT programs for fresh trainers.

With all the above programs, SCMS re-certified/ certified 71 assessors and 52 trainers. In total 114 assessor certifications and 90 trainer certifications were awarded. In total, as on 31st March 2023 SCMS has a pool of 308 Trainer/ Master Trainer certifications & 397 Assessors/ Master Assessors certifications.

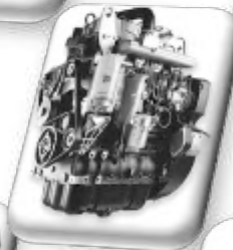

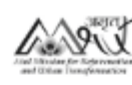

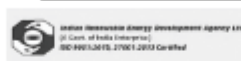
