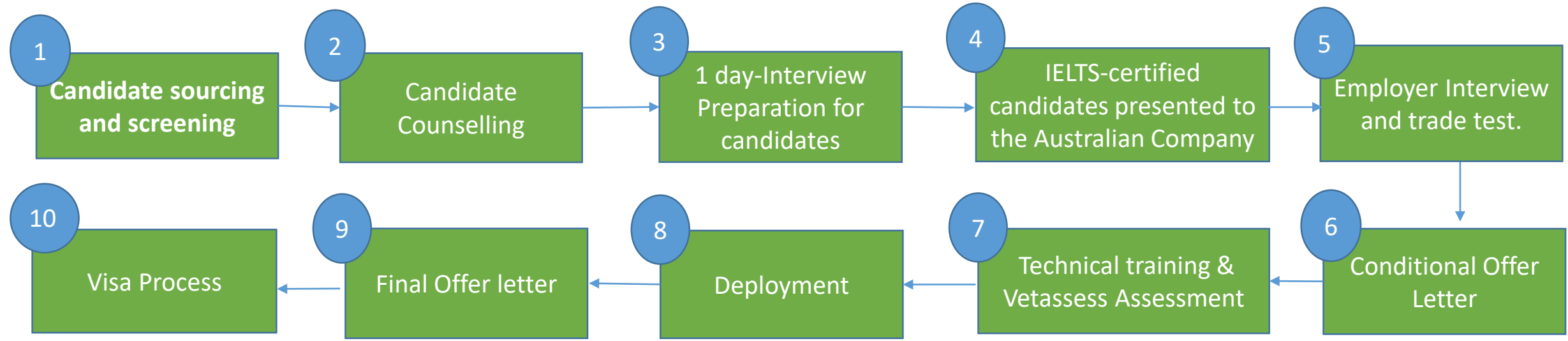
## About SCMS

- ❖ SCMS is an **apex body to train and meet the requirement of skilled workforce for the mining** industry in PPP mode, **promoted by FIMI, supported by Ministry of Mines and approved by the NSDC** under the Ministry of Skill Development (**MSDE**)
- ❖ Ministry of Skill Development and Entrepreneurship (MSDE) in its gazette notification dated 17th March 2015 has **authorized SCMS as a non-statutory agency for certifying the mining workforce** in India.
- ❖ SCMS is a **registered company** under **section 8** of companies' act 2013 and has been issued **80G certificate** under income tax act 1961 in October, 2015. This allows SCMS to take training programs under Cooperate Social Responsibility (**CSR**).
- ❖ CEO-SCMS is designated as **Joint Apprentice Advisor (JAA)** for Optional Trades vide MSDE notification no MSDE-01/(3)/2018-AP(PMU) dated 12 September 2018
- ❖ SCMS, as an awarding body, is **recognized and regulated by NCVET** under the edges of MSDE

**Process flow for Demand - Deployment (Up to 6 Months with IELTS)**

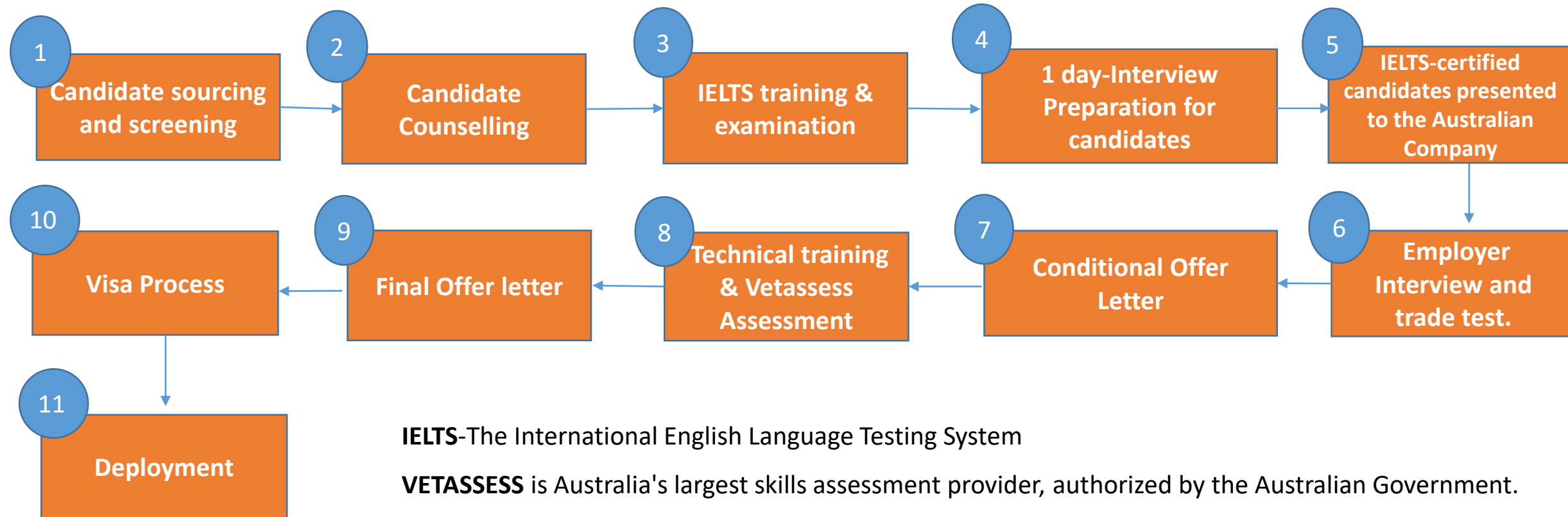
