SECTION II: NOTICE INVITING EOI

Introduction:

Skill Council for Mining Sector (SCMS) promoted by FIMI and supported by Ministry of Mines was established in December, 2013 as the apex body to train and meet the requirement of skilled workforce for the mining industry in PPP mode. SCMS was setup by National Skill Development Corporation (NSDC) under the Ministry of Skill Development & Entrepreneurship (MSDE). Ministry of Skill Development and Entrepreneurship (MSDE) in its notification dated 17th March 2015 has authorized SCMS as a non-statutory agency for certifying the mining workforce in India. SCMS is also recognized by NCVET as ‘Awarding Body’ for NSQF compliant skill certification. SCMS is a registered company under Section 8 of Company’s Act 2013 and has been issued 80G certificate & 12AA certificate under Income Tax Act 1961 in October 2015.

The core activity of SCMS is to formulate the National Occupational Standard (NOS) for different job roles aligned to National Skills Qualifications Framework (NSQF) notified by Government of India, in December, 2013. SCMS has carried out Occupational Mapping and Skills Gap Studies for sector. It has developed skill competency standards i.e. qualification packs and curriculum aligned to NSQF levels benchmarking it with national and international standards for both opencast and underground mines.
